Terms and Conditions of Licence for Market Research Reports

1. DEFINITIONS & INTERPRETATION

Intelligent & Green Systems Ltd provides market research and business intelligence reports and products (“Reports”) as well as other types of content and services (“Services”) through the web site located at www.igsystems.co.uk.com (the “Site”). All access to and use of the Site and all Reports and Services is subject to the terms of this Agreement.

The “Agreement” means the Agreement between Intelligent & Green Systems Ltd and the Customer to provide a Licence for the use of the Research Report(s) for Fees on these terms and conditions of business.

“I&G” is Intelligent & Green Systems Ltd.

“Customer” means the person or entity purchasing the Licence for the use of the Research Report(s).

“Research Report” means a written document containing I&G copyright materials such as data, information, insight, commentary, either written, oral, video, or audio.

“Proprietary Information” means all information contained in the Research Report(s) and associated briefings or presentations by I&G, plus all logos, processes, third party data and formats contained therein.

“IP” means any and all intellectual property, proprietary rights, rights of publicity, rights of privacy, and any and all other legal rights protecting Content, information or intangible property throughout the world, including, without limitation, any and all copyrights, trademarks, service marks, trade secrets, patent rights, moral rights and contract rights.

“Fees” means the fees payable by the Customer to I&G, as set out in the Contract.

2. LICENSES

2.1 Standard License: Upon acceptance of an order for a “Standard” license, I&G shall grant the Customer a worldwide, non-exclusive, non-transferable license to a single named user within the Customer’s organisation to: (a) download, store and display one electronic copy of the Research Report in machine readable form; and (b) print additional paper copies of the Research Report for internal business use within The Customer’s organisation.

The Customer is entitled to extract elements of the Research Report and re-use them for internal and external presentations, subject to the doctrine of Fair Use, provided that I&G is, in each case, cited as the source.

Notwithstanding the foregoing, under a Standard License the Customer shall NOT be permitted to:

(a) transmit the Research Report(s) to any third party, which shall include any agencies, contractors, Representative Organisations, without the express written permission of I&G, and the payment of additional Fees as determined by I&G commensurate with a Multiple User Licence.

(b) modify or alter the Research Report or create a database in electronic or structured manual form by systematically downloading and storing any of the content from such products other than for internal business purposes; and

(d) download, store, reproduce, transmit, display, copy, distribute, commercially exploit or use the Product other than as expressly permitted above;

2.2 Enterprise License: Upon acceptance of an order for an "Enterprise" license, I&G shall grant the Customer a worldwide, non-exclusive, non-transferable license to: (a) download, store, transmit and display multiple electronic copies of the relevant Research Report, in machine readable form, to employees of his/her company; and (b) print additional paper copies of the Product for internal business use within The Customer's organisation.

The Customer is entitled to extract elements of the Research Report and re-use them for internal and external presentations, subject to the doctrine of Fair Use, provided that I&G is, in each case, cited as the source.

Notwithstanding the foregoing, under an Enterprise License the Customer shall NOT be permitted to:

(a) transmit the Research Report(s) to any third party, which shall include any agencies, contractors, Representative Organisations, without the express written permission of I&G, and the payment of additional Fees as determined by I&G commensurate with a Multiple User Licence.

(b) modify or alter the Research Report or create a database in electronic or structured manual form by systematically downloading and storing any of the content from such products other than for internal business purposes; and

(d) download, store, reproduce, transmit, display, copy, distribute, commercially exploit or use the product other than as expressly permitted above;

3. CONFIDENTIALITY

All Research Reports, and any information disclosed or made available by I&G under this Agreement that relates to I&G or to the preparation, provision or receipt of any Reports or related content, are and will remain the "Confidential Information" of I&G, except as strictly required to use the Research Report pursuant to these License Terms. Both parties shall keep any confidential information shared between them as part of this Agreement confidential, except when entitled or bound to disclose under compulsion of law.

4. OWNERSHIP OF INTELLECTUAL PROPERTY

I&G retains all right, title and interest, including, without limitation, all IP, in and to all Services and Reports, all Content therein, and any additions, improvements, updates or modifications thereto. The Customer acknowledge that they are not receiving any ownership interest in or to any of the foregoing. The I&G name, logo, and the names associated with the Site and all Services and Reports are trademarks of I&G or third parties, and no right or license is granted to The Customer to use them separate from the rights expressly granted to the Customer under this Agreement.

5. FEES & PAYMENT

All fees are as set forth on the Site or official I&G correspondence with the Customer. I&G will invoice the Client for all Fees for applicable Orders or Confirmations, with payments due within 30 days from date of invoice issued by I&G. All files are downloaded from the Internet and paid for by The Customer only once.

Any Fees that are not paid as of the due date will accrue interest at 1.5% per month (or the highest amount allowed by law) until paid. All fees are non-refundable once paid to I&G (including upon any termination or suspension of this Agreement).
